## // Context and objectives

Urban Europe is diverse but united in its need for empowerment. Cities are laboratories for ecological transition, innovation, and inclusion. Yet their contribution to Cohesion Policy remains constrained by governance asymmetries and uneven access to resources.

Over recent programming periods, cities have been given a greater role in the EU budget, reflecting their growing recognition as key actors in achieving territorial cohesion and driving green and digital transitions.

Building on these advancements, the post-2027 period offers an opportunity to further strengthen the contribution of cities by aligning EU funding with local strategies, enhancing multilevel governance, and addressing capacity gaps. These steps can help ensure that Cohesion Policy continues to deliver effectively on its mission of promoting balanced and inclusive territorial development across Europe.

This ESPON Conference, organized in cooperation with the stakeholders and partners of ESPON URDICO, will address the urban dimension of Cohesion Policy, presenting new evidence from the [ESPON URDICO project](#). URDICO explores how European cities implement the urban dimension of Cohesion Policy and use EU funds to promote sustainable, inclusive, and resilient urban development. By comparing governance models, funding synergies, and institutional innovations across diverse cities, the study identifies practical lessons for more effective multilevel urban governance. URDICO sheds light on both the good practices and the challenges related to cities role, providing evidence to support implementation in 2021–2027 and to inform thinking on potential developments after 2028.

This conference will foster dialogue among city representatives, researchers, national and EU policymakers on how to strengthen the role of cities in delivering Cohesion Policy. A keynote on the EU Agenda for Cities will outline future priorities for EU support to urban areas, feeding into the debate on the post-2027 Cohesion Policy framework.

Representatives from the European Commission, the European Parliament, the Committee of the Regions, national authorities and cities will join the discussion to help shape evidence-based, forward-looking approaches to urban governance across Europe.

Key objective of the conference:

- Presentation of the urban dimension of the EU Cohesion Policy from the ESPON URDICO Project, based on evidences collected from 8 cities.
- Discussion on how the URDICO evidence could be useful in implementing the urban dimension of the Cohesion Policy.
- Provide a platform for dialogue and discussion with representatives of cities and key EU institutions in charge of Cohesion Policy.

Target groups:

- Local stakeholders, in particular city representatives involved in the implementation of the Cohesion Policy.
- National and regional stakeholders, in particular authorities involved in the negotiation and strategic designing of the Cohesion Policy.
- European-level policymakers and institutional representatives engaged in Cohesion Policy and territorial development.
- Media covering EU policy and urban topics.

Rotterdam illustrates how decentralised governance empowers cities such as Managing Authorities or Intermediate Bodies; Prague show partial co-decision; Budapest's capacity remains unused due to limited cooperation at the national level.
